The dreaded dues reminder

Dues notices have been sent to each member with reminders at meetings and with the notices of the date they are due At the risk of being repetitious, dues are due April 1 and can be paid any time between April 1 and May 31. They are delinquent as of June 1. To avoid a \$10 delinquent fee, it's best to pay them by the final due date of May 31.

You will see in a later article that the committee who met to prepare proposals for bylaws are recommending some changes to Article XII as applied to the dues. The recommendation is to change

the wording to allow for 1/2 paid by June 1 and the second half by January 1. It would also allow for alternate arrangements if a member needed additional consideration to be approved by the Board.

The dues increase which is proposed, if passed, would take effect on July 1, 2018. Obviously the club needs to collect sufficient income to cover club costs and we need to forward SIA/SI dues and Region dues by July 1 of each year. The club has been able to budget for a carryover from the previous club year to provide a cushion for the start of the new year. However, we

also have other costs at the start of a new year which we have to have sufficient funds to cover. The goal is to ease an onerous burden on a member that might occur by her paying dues in full when an adjusted schedule of payment would enable her to better continue her membership. Please contact the Board who is willing to work this out if it is necessary. The ultimate goal is adding new members as this generates more income and improves the club's ability to meet costs in order to keep the club up and running.

GWR Spring Conference

The Region's annual Spring Conference will be in Pala, California, at the Pala Casino Spa Resort and the Call has been issued to each member. SI Chino Hills Inland Empire, SI San Jacinto-HemetValley and SI Moreno Valley are sharing the hostess duties. The first event begins on Thursday with the Soroptimist Summit. The focus is Building Access to Education. This will be followed with a Wine Cave Cocktail party and Governor Penny will introduce the 2016/2018 committee members.

Six of the club's members are attending at various times. They are Cathie, Michelle, Gladys, Lupe, Judy and Barb C. The proposed changes to Region bylaws was discussed at the May business meeting and delegates will be attending the Delegate's Briefing on Friday morning to prepare for the voting process at the business meeting. It is a chance to question, clarify and comment on the proposals to enable a smooth discussion and vote during the business session. Delegates will also vote on Officers and District Directors as well as the proposed budget for the coming

year.

There will also be numerous workshops on Friday and Saturday on a variety of subjects pertinent to Soroptimist interests. The Conference Theme is Soroptimist Soaring with some discovering, dreaming and exploring thrown in.

Conferences are always a very special event and a great time to meet and make new friends and join with old friends from other clubs in the Region.

Time for a change

Change for the sake of change is never a good idea, but it is sometimes necessary to review old procedures, laws, rules, traditions and protocols to insure the needs of the club are being properly met and are current with changes in lifestyle and attitudes and thinking of potential members as well as current members. Therefore the club's bylaws and standing rules were viewed by a committee and their proposals for changes have been sent to the members and discussed at the May business meeting. They will be read again

at the June business meeting and a vote conducted on each proposal at that time. Much of the suggestions were merely housekeeping. Some wording that no longer applies is being deleted. A proposal to increase the dues by \$20.00 will be on the agenda to help with increased administrative costs. It's a process not unlike the handling of our personal finances as costs continue to rise for them as well. It has been a number of years since we last increased the dues and it's time to address this issue again. Twenty dollars spread

over a year is less than a \$1.75 a month increase. In the meantime, the members can be as creative as they can be to discover new ways to earn monies for the club in the future.

Bookkeeping

Bookkeeping is not a dirty word, but it is a chore that must be done. It is essential to have accurate procedures for accounting for the club's monies. Not only are club's accountable to their members, but also to various government agencies as we are a non-profit organization. California clubs have the added requirement of collecting and reporting sales tax on any item we sell. This includes auction items and other goods that have a value such as yard sales.

This is paid to the California Franchise Tax Board yearly. At the end of the fiscal year an accounting of a Profit and Loss Statement summarized for the accounting firm who prepares the tax papers for the club must be completed. At the end of the fiscal club year, the accounting records of the Treasurer is reviewed and "audited" for purposes of insuring the club's monies are properly accounted for. This is for the protection of the members

as well as the Treasurer. Following the audit, the Finance Committee is also responsible for preparing a proposed budget for the new club year.

We are not just another pretty face, but serious in operating as good business stewards of the clubs monies.
