A look at the club's finances

It has been discussed early in the club year that it would be prudent to review the club's financial position mid-year to check how the club stands with regard to the General Budget passed by the members in September.

It is not the intent to change the line items that are a part of the budget. It is, however, for the purpose of evaluating the amounts budgeted for each line item to spot potential shortages to determine if the amounts may need to be amended up or down. If necessary, a recommendation to amend the budget will be made and the members will be asked to discuss the recommendation and subsequently vote on whether or not recommended changes should be accepted. A majority vote will decide It is possible that a review will show no changes are indicated and the budget will stand as approved at the beginning of the club year. The decision of how much and for what purpose the money should be allocated is for the members to decide. Any member who is tasked on a project that involves spending the club's money, must insure she has approval for these expenses before spending any money Reimbursement is not automatic when a members asks for reimbursement without prior approval from the members. Fiscal responsibility is essential to a healthy club.

How much do you know?

A well informed member is a valuable asset to the club. By-laws and Standing Rules are developed for a reason. They serve as a reference and guide as to what is OK and what is not. They are developed and accepted by a vote of the members; and therefore, not subject to changes on the whim of an uninformed member or by a member who believes she knows better. There is a process to follow. If the Laws and Procedures need to be changed to keep current with changes in what the club needs or to keep current with Region's and Federation's laws as well as the SI Constitution the members will have an opportunity to decide by a vote what changes to make based on the recommendations of the Laws and Resolutions Committee.

In order to stay current with the bylaws and standing rules you will find that rereading them periodically helps. It's easy for memories to become clouded and we don't remember as accurately as we might think.

Who can make a motion? (parliamentary procedure)

Why does a motion require a member to second it before asking for discussion? (parliamentary procedure)
